PUBLIC HEALTH (TOBACCO) ACT 2002 (COMMENCEMENT)
ORDER 2008

I, MARY HARNEY, Minister for Health and Children, in exercise of the powers conferred on me by section 1(2) of the Public Health (Tobacco) Act 2002 (No. 6 of 2002), hereby order as follows:

1. This Order may be cited as the Public Health (Tobacco) Act 2002 (Commencement) Order 2008.

2. In this Order “Act of 2004” means the Public Health (Tobacco) (Amendment) Act 2004 (No. 6 of 2004).

3. The 1st day of July 2009 is appointed as the day on which the following provisions of the Public Health (Tobacco) Act 2002 (No. 6 of 2002) come into operation—

- (a) section 33 (inserted by section 5 of the Act of 2004),
- (b) section 35 (inserted by section 6 of the Act of 2004),
- (c) section 36 (inserted by section 7 of the Act of 2004),
- (d) section 37 (inserted by section 8 of the Act of 2004),
- (e) subsections (2), (4), (6), (7), (8), (9), (10) and (11) of section 38 (inserted by section 9 of the Act of 2004),
- (f) section 39 (as amended by section 10 of the Act of 2004),
- (g) section 42 (inserted by section 13 of the Act of 2004),
- (h) section 43 (inserted by section 14 of the Act of 2004), and
- (i) section 44.

This Order may be cited as Public Health (Tobacco) Act 2002 (Commencement) Order 2008.

This Order commences sections 33, 35, 36, 37, subsections (2), (4), (6), (7), (8), (9), (10) and (11) of section 38, 39, 42, 43 and 44 of the Public Health (Tobacco) Act 2002 (No. 6 of 2002) with effect from 1 July 2009.
